Sex Offender Information Bulletin

The New Berlin Police Department, in cooperation with the Sex Offender Registration Committee, is releasing the following information pursuant to Wisconsin State Statute 301.46 which authorizes law enforcement agencies to inform the public of a sex offender's location when: in the direction of the agency, the release of that information will enhance public safety, awareness and protection.

The individual who appears on this notification has been convicted of a sex offense. Further, his criminal history places him in a classification level which reflects the *potential* to reoffend.

The sex offender has served the incarceration sentence imposed by the courts. The offender, under the supervision of the Department of Corrections, Division of Community Corrections, will be living in the location listed below. **HE IS NOT wanted by the police at this time. This notification is not intended to increase fear; rather, it is our belief that an informed public is a safer public.**

Sex offenders **have always** lived in our communities; but it was not until Act 440 (June 1997) was enacted that permitted law enforcement to share this information with the community. Citizen abuse of this information to *threaten or harass* registered sex offenders will NOT be tolerated. Please understand that such abuse could potentially end law enforcement's ability to do community notifications. We believe **the only people who win if community notification ends are the sex offenders**, since sex offenders derive their power from secrecy.

Offender's victims (separate New Berlin incidents) included a juvenile male, at which time the offender was a juvenile, and a juvenile female, at which time the offender was an adult. Both victims were acquaintances of the offender. Offender is to have no unsupervised visits with minors, no contact with victim(s) and not to consume drugs. He is to comply with standard sex offender rules and cooperate with electronic monitoring. Fact to face contact with law enforcement is required, and he is to comply with all requirements of the WI Sex Offender Registry.
